## **PRIVACY POLICY**

North Syracuse Education Foundation, an organization in Cicero-North Syracuse, serves a simple, but comprehensive purpose – to ensure that students in the North Syracuse Central School District have the benefit of a quality education, to maintain and enhance the level of excellence in North Syracuse schools, and to respond to the realities of diminishing local and federal funding.

This privacy policy pertains solely to all operations and services provided by, or therefore used from, this web site for North Syracuse Education Foundation, located at <http://www.nsefweb.org>.

### **1.0 Privacy Statement**

1.1 It is the main interest of our (“our” being the entity of North Syracuse Education Foundation) organization, the North Syracuse Education Foundation, to acknowledge the privacy of each user (“user” being defined as any person that accesses the North Syracuse Education Foundation web site located at <http://www.nsefweb.org>) that visits our web site. Information from each user that visits our web site, located at <http://www.nsefweb.org>, is gathered for research and statistics by our organization, and it is our primary desire to familiarize each user of our web site with the terms and conditions of the collection, use, disclosure, and maintenance of the information we (“we” referring to the entity of the North Syracuse Education Foundation) made available to us by your accessing of our web site.

### **2.0 Information Collection and Use**

- 2.1 The information that our organization, the North Syracuse Education Foundation, collects includes, and is limited to, the basic IP address of each user upon first entrance to our main web site (our main “web site” being located at <http://www.nsefweb.org>).
- 2.2 In the collection of user data by our organization, we hope to receive information that will guide our services to best suit its users. More specifically, the IP address collected from each visitor to our main web site is primarily used to track the general location of the users of our web site, such as a specific city or region (i.e. Northeastern United States, New York City).
- 2.3 In compliance with the Children’s Online Privacy Protection Act of 1998, our organization does not knowingly or intentionally collect information from or regarding any individual under the age of 13.

2.4 Collection of alumni data under the NSCS Alumni section is only collected when provided by the user or the North Syracuse Central School District, and is used as a contact base for newsletters, updates, and dissemination of information regarding the North Syracuse Education Foundation.

### **3.0 Maintenance of Information**

3.1 All information that our organization, the North Syracuse Education Foundation, collects is maintained in a secure database on the Internet, which is furthermore password protected.

### **4.0 Disclosure of Information**

4.1 The information that our organization, the North Syracuse Education Foundation, collects and maintains is never disclosed to third-party sources or any individual or entity outside of our organization, with the exception of individuals or entities involved in legal processes. In such legal processes, our organization will have no choice in such matters.

4.2 Each executive of the North Syracuse Education Foundation, as well as DeSalvo Web Sites, is obligated to keep the confidentiality of every aspect of information they review regarding a customer or user of the web site located at <http://www.nsefweb.org>.
